The Job Description

You will draft, review and negotiate legal agreements on behalf of Leiden University Medical Centre (LUMC) related to the funding of clinical research and/or IP protection and exploitation. Such agreements may include research collaboration agreements, consortium agreements, clinical trial agreements (CTA's), service agreements or material transfers. The agreements maybe with other academic institutions, or commercial partners, you will work closely with academics as well as your Luris colleagues to advise and negotiate high quality agreements which protect the interests of LUMC and enable academic research to progress. The agreements are in the English language, but typically under Dutch Law.

Your Profile

- You have completed academic qualifications in (Dutch) Law and have a good knowledge of contract law, intellectual property law and health law, preferably in the field of clinical research;
- You have some legal working experience at a research institution or other service provider;
- some experience with drafting and reviewing agreements related to public private partnerships is an advantage
- experience in drafting and reviewing CTA's (Clinical Trial Agreements) is an advantage;
- an interest in 'life sciences' and affinity in working in an academic environment;
- outstanding verbal and written communication skills in English, and preferably Dutch;
- Pragmatic, conscientious and systematic work ethic;
- Flexible and intuitive, enjoys working in a diverse team focussed on making an impact of society.

Description of Luris

Luris is a progressive and modern technology transfer office. We support scientists and academics from Leiden University and LUMC in their ambition to progress their research, and to bring their research to market to generate a positive impact on society. Luris sets up projects, manages relationships as well as investments with companies, social organizations, grant providers and Government.

We offer

The appointment is at Leiden University, initially for the duration of 1 year with a trial period of 2 months. A contract extension is possible subject to need and performance. The salary scale, depending on experience and qualifications, is minimum €3637 to a maximum €5656,- gross per month, assuming a full time position (salary scale 11 to 12). For senior lawyers the maximum extends to €6133,- bruto per maand (scale 13) – subject to experience.

In addition Leiden University has very good working conditions. There is a year-end bonus (8,3%), holiday bonus (8%), excellent training facilities, paid parental leave, sabbatical leave and the possibility of flexible working conditions. Further information is available at:
